Textual Information()

Company is in process of calling First and Final Call Money on Partly Paid-Up shares of the Company. Company sent first call notice dated 01st January, 2024 for which allotment was completed on 25th January, 2024 and listing approval obtained on 02nd February, 2024 for 33,53,121 and obtained trading approval on 16th February, 2024 for 33,24,097. In continuation to this during corporate action process 29,024 shares were not credited to certain shareholders due to incomplete data provided by shareholders to Depositories and RTA. RTA of Company is in touch with shareholders for completing Corporate Action for such cases.

Further Reminder notice was sent to shareholders on 14th February, 2024 for which allotment was completed on 19th March, 2024 and listing approval obtained on 28th March, 2024 for 7,80,163. As on quarter ending date corporate action and trading approval was pending for said number of shares under First Reminder call.

Due to above mentioned reasons, there is aggregate difference of 8,09,187 shares [29,204 (First Call) & 7,80,163 (First Reminder)] in Benpos data and Issued & Listed Capital of the Company.
